



STANDARD SUPPLEMENTARY REGULATIONS PART ONE – 27 February 2022, Cromwell Street Sprints

1. JURISDICTION

This event is a ClubSport Advanced Event, promoted by the Central Otago Motorsport Club on a public Road in Cromwell Industrial Area.

- Cromwell Industrial Area (Wolter Cres, Hughes Cres, Cemetery Road, Connelly Way, Chardonnay Street, Pinot Noir Drive, Central Otago. (Surface: Tarmac.)

The Meeting will be held under these Supplementary Regulations, the MotorSport NZ National Sporting Code and its Appendices and Schedules particularly Appendix Five, Schedule C being the Standing Regulations for all ClubSport Events and Appendix Two, Schedule A – Driver and Vehicle Safety Requirements. except for pre 1978 Schedule K, T&C or Cr compliance with Appendix 6 Schedule AA. Motorsport Manual (available online at www.motorsport.org.nz). Open wheelers, Cross cars or similar not permitted to run. Electric or Hybrid cars or similar not permitted to run.

M Licence (or greater) and Roll Protection (1/2 Cage or greater) required

COVID 19 – The event will be run as per COVID 19 restrictions that may in place at the time of event starting, including requiring Vaccine Passes. It will be up to the Street Sprint committee and COMC to enforce these procedures as advised and in accordance with MSNZ recommendations.

3. **EVENT DESCRIPTION:**

3.1 The event will consist of a single car tarmac sprint as per Appendix 5 Schedule C. There will be two cars on track at a time, the second car will not be released until the first car is on Wolter Crescent heading to finish. The event Clerk of the Course will advise Drivers at drivers briefing the format of the day

3.2 **Classes:** Vehicles will be divided into the following classes:

4. **ENTRIES:**

Alternatively, entries may be submitted manually in 'hard copy' form. All such entries must be made on the correct form, must be complete in all detail, and accompanied by the appropriate fees.

By sending (either by possum, hard copy, or digital copy) an entry form is considered an expression of interest in the event, receiving an acceptance letter **only** is confirmation of your entry into event. Street Sprint Committee decisions on entrants' acceptance letters are final.

Organisers reserve the right to refuse any entry in accordance with the prescribed provisions of the National Sporting Code.

4.2 **Opening and Closing Dates:**

Entries open with the publication of these regulations and close (at normal fees) on 4th February 2022

Entries received after the normal fee-closing date are subject to late fee. No further entries after 18th February 2022.

Acceptance Letters will begin to be sent from 4th February 2022.

4.3 **Entry Fees:**

Appropriate fee payable at the time of entry.

The Entry fee for this event is \$140, including GST per competitor.

The late entry fee for this event is \$160, including GST per competitor.

Commemorative competitor t-shirt will be available for a cost of \$ 35.00 – tick box on entry forms

4.4 Number of Starters: The maximum number of starters will be 55 (Max 2 Drivers per car). Any additional entries received will be placed on the reserve list.

5. COMPETITOR REQUIREMENTS and UNDERSTANDING:

5.1 Licence Requirements:

All drivers must hold as a minimum an M Grade Competition Licence and current membership with a member club.

If the Entrant is other than a driver, an Entrants licence in the name of the Entrant is required.

5.2 Competitor Understanding:

In submitting the entry competitors (Entrant and Drivers) are deemed to fully understand the MotorSport NZ National Sporting Code and its relevant Appendices and Schedules. In particular:

- The National Sporting Code Articles pertaining to protests and competitor's obligations, and
- Appendix Five, Schedule C.
- COMC Code of Conduct and Health and safety policy (see point)

Verbal or Physical abuse of any kind to any Marshal and/or COMC/MSNZ official will not be tolerated and will be dealt with severely.

5.3 All competitors shall wear safety apparel in compliance with Appendix Two, Schedule A.

6. ELIGIBLE VEHICLES

6.1 Compliance: All vehicles shall comply with Appendix Five Schedule C and Appendix Two Schedule A and Schedule AA (PRE 1978) of the current MotorSport Manual unless stated otherwise in these supplementary regulations. . A double strapped fire extinguisher fitted near driver is mandatory.

Race vehicle numbers need to be clearly visible to the timing caravan (and finish line), if you have multiple numbers on your car please cover up the ones not relating to this event, if you have two drivers per car, make sure you cover up the number for the driver not racing, please make sure the numbers are contrasting colour to your vehicle, to make it easier to see (bigger is better).

Basically, we are recording times against your car race number if the timing people can't clearly and easily see your car number, you may not get a time. Scrutineers may check this at event and request you fix before starting.

7. DOCUMENTATION & SCRUTINEERING AUDIT INSPECTION

7.1 Documentation: From from 2pm to 5pm at R&R Hiab Services, corner Rodgers St and Barry Ave on Saturday February 26th 2022. Documentation not completed during this time, is only by prior arrangement.

Competitors must present themselves at Documentation for the checking of all licences and documents, issuing of competition numbers and applicable advertising material prior to presenting the car/logbook for Scrutineering.

7.2 Scrutineering Audit Inspection: From 2pm to 5pm at R&R Hiab Services, corner Rodgers St and Barry Ave on Saturday February 26th 2022. **No** Scrutineering done on race day; earlier scrutineering is only by prior arrangement.

Reminder if you are at one of your two allowed "No Audits", you only need to bring your logbook, for sign off, you don't need to bring the car. Ask event secretary if unsure.

All race vehicles that come to scrutineering are to be trailed/towed unless they are road legal (warranted and registered). Any race vehicle that is driven to scrutineering which isn't road legal will forfeit their event entry and will not receive a refund. They could also be blacklisted from future events held by COMC.

Reminder to those people who are also entered in the Highlands Sprint Series Round 3 will be held on 26 February, which is Street Sprints Documentation and Scrutineering, so you will need to organise **beforehand** your Documentation and Scrutineering with us. You may like to consider having your vehicle scrutineered at Highlands, so our event the next day only requires a "no audit" sign off. Whatever you do, make sure to organise with us in advance. Don't leave it to the weekend – see clause 10.3.

7.3 Drivers' Briefing: This will be held at Pits Area commencing at about 8:15am. Attendance by **all drivers** is compulsory – a roll call will be taken and failure to attend will result in a not racing with no refund.

7.4 Pit Boss: The Pit Boss is an important official on the day. They will ensure that they get everyone organised in their race order and everyone gets opportunity to complete their allocated 3 round, they will also be passing on any Clerk of the Course instructions or decisions. Your responsibility as a driver is to ensure that you listen to them and do as instructed, For any misconduct that happens during the event, the Pit Boss (in consultation will Clerk of Course) will have authority to penalise entrants (which can include time penalties through to "trailer your vehicle" order and you will have to leave the event). This could also compromise any future COMC events that you try to entry.

8. POSTPONEMENT CANCELLATION ABANDONMENT & ORGANISERS' RIGHTS:

8.1 Pursuant to national Sporting Code Article 13, the organisers advise that if less than 20 entries are received by the entry closing date the meeting may be postponed or cancelled.

9. OFFICIAL BULLETINS

9.1 Official Bulletins may be issued in accordance with the provisions of the National Sporting Code.

10. GENERAL INFORMATION

10.1 Passengers: May only be carried in accordance with Appendix Five, Schedule C Article 6.2.

10.2 Alcohol or non-prescribed medication or other drugs are **not** permitted to be consumed by any competitor or their crew at the event, before or during the day's competition.

10.3 Entry Fee Refund Policy

The Organisers advise that entry fees will only be refunded in full or part under the following conditions.

A) Cancellation of the meeting prior to the commencement of documentation – Full refund.

B) Withdrawal prior to the commencement of documentation – Full refund.

C) Withdrawal after the completion of Documentation but before competition – refund of 50% of entry fee.

D) For reasons of Force Majeure should an Event or part thereof be cancelled any entry fee refund will be made only at the discretion of the event organisers. The organisers reserve the right to cancel or abandon the Meeting or part thereof, under Force Majeure.

There will be no refunds and you will not be racing on the day, if you have not completed documentation and scrutineering by 5pm Saturday 26 February 2022, unless contact is made before 5pm Saturday, and there are extenuating circumstances as to why, it will be at the Street Sprints committee discretion and decision is final if allowed to run or not.

10.4 Noise Restrictions

Maximum permitted noise limit is **85db** as per schedule A, to be able to continue to get the event in the future, Clerk of the Course may request drivers to reduce any deemed excessive noise.

10.5 Timing/Runs

The organisers of the event will endeavour to time the sprint with an electronic timing system. In case of failure manual timing will be used. Results will be provided as soon as possible. Competitor's, pit crew and public are to keep away from the timing caravan. These guys working in caravan are doing their best to concentrate and make day run smooth. Any issues should be sorted with Pit Boss or Event Secretary and/or Clerk of the Course.

The results for this event will be posted with the winners being the persons with the fastest times of the day for each of the allocated classes. These results will be taken from the completed 3 official runs. This will determine finishing positions for all classes.

Should the event be stopped prior to the end of an official run then the last completed run will be used for results purposes-runs will be allowed on official runs caused by timing issues. No re-runs other than missed times – NO EXCEPTIONS

The number of officially timed runs in the event will be dependent on the amount of time available to organisers and or at the discretion of the Clerk of the Course. Missed times or red flagged laps (not caused by driver) will be re-run at the end of each run

Top Ten Shoot Out

This will be based on the top ten fastest cars throughout the official timed runs. This shoot out is to determine overall top ten placings. Top 10 winner's 1st, 2nd and 3rd are not eligible for Class prizes

The top ten shoot out will be 1 run per car and fastest time 1- 10 will determine the final top ten overall placings for the day. The times from the 3 official runs will not be part of the top ten shoot out.

Should the Top ten shoot out not commence or be completed, then fastest times of qualifying rounds will determine overall results.

10.6 Tyres/Loss of Traction

NO Slicks or rally tyres are permitted. NO Stationary Burn Outs are permitted. There are NO Warmup or Cool Down Laps. There is No warmup area in pits or on Gair Ave.

The pit area has speed restriction of 15 kms and strictly no loss of traction allowed. Exceeding speed limit or loss of traction will result in car being trailered with no refund.

10.7 Cones/Hay Bales

A 5 second penalty will be incurred for each contact with a chicane cone or tyre. If vehicle hits and moves a hay bale, it will result in DNF – no re-run will be allowed.

Vehicle recovery will be done as quickly and safely as possible but COMC and/or any persons involved in helping with the recovery are not held liable for any further damage to vehicle. This is the competitor's responsibility. Efforts will be made to return the car to pits following the incident, however the organisers have the right to move the vehicle to a safe position and continue the runs and bring the car to the pits at the end of the run or next available time (clerk of Course's discretion).

10.8 Parking/Trailers

Please Park where directed by any event official. It is strongly advised to drop off race car and gear in pits. Then take trailer and park on grass outside pit entrance. This way we are not congesting pit area as we are limited on space.

10.9 Fuel Handling

Competitors are reminded that they are required to be familiar with the MotorSport New Zealand Code of Practice for Motorsport Fuel - Storage and Handling. Details are available on the MotorSport New Zealand website: www.motorsport.org.nz/pdf/code%20of%20practice%20fuel.pdf

The entire pit area and competition surface are a smoke free zone.

Any competitor running non-pump fuel (ethanol etc) are required to advise officials at drivers briefing so that safety personnel are aware of this.

10.10 Code of Conduct

All entrants are deemed to have read and accepted our code of conduct, and by attending/entering our event have agreed to abide by them.

10.11 Multi Driver Cars

Multiple run cars or double entered drivers may be accepted at the discretion of the organisers.

10.12 Other Matters

- All cars will remain in the pit area when not on the track.
- Competitors are responsible for their crews and guests at all times. Please ensure all non-competing persons are within designated spectating or pit areas. All competitor and crew rubbish must be taken away with you. Please ensure you and your crew arrive, exit and conduct yourselves at the venue without noise or behaviour that might irritate residents or the public.
- Competitors will be responsible for the cost of repairing any damage they or their team cause to any track property, plant, or equipment. "You break it, you fix it"
- Toilet facilities are available on site.
- Food and Drink will be available from the Lions and other vendors.
- No Spectators in the Pits, just competitors and their crew.

MSNZ Insurance

Everybody accepts by entering the event that they, the competitors are liable for any damages caused during competition minus any payment made by the insurer under any approved claims made against the MotorSport New Zealand Public Liability insurance policy. In almost every case, this means the competitor will only be liable up to the excess amount of \$3,500. As with any insurance policy, there is always the possibility that a claim may be declined and therefore a competitor may be required to cover any cost for repairs that they have caused if that claim is declined. Occasions that a claim may be declined are based around such things as, but not limited to non-compliance with the MSNZ rules regulations or policies; the person(s) involved being under the influence of drugs or alcohol.

Video Cameras (Go Pro)

Please note also that Video cameras are not allowed to be attached to helmets at any MSNZ event.

Refuelling Race Cars

When refuelling race cars at events, a reminder, you should be in your race gear (preferable with Gloves and Balaclava) for person pouring fuel and a person in race gear should be on standby with fire extinguisher. Clerk of the Course will be reminding at drivers briefing and for everyone's safety please remember to do so.

11 POST EVENT REFRESHMENTS

Prize giving will take place following the event from 5.00pm at the Victoria Arms Hotel, Melmore Terrace, Cromwell. All competitors are encouraged to attend. Official prize giving will start at 5.45pm approximately.
